IV. Old Business:

a. Strategic Plan Update: We discussed that we are proceeding on following our designated plan. We are seeing academic growth during our Tier 2/Tier 3 Intervention Monitoring. We have finished 3 books for our Personalized Learning preparation for Fall 2018. We have diligently prepared our lessons and our students for Core 4 Educational Elements by beginning/using each element in our classrooms on a daily basis. And we have continued to have academic activities where parents/community are involved in with our children to incorporate the village-wide emphasis on educational engagement.

b. Title 1 Update: We have completed our 2nd Semester Community Meeting and followed it up with our Dr. Seuss Day reading and book giveaway. It was well received. We have activities coming up via Title 1: Books for Bingo on April 18th and have invited the community to share in our afternoon.

c. Tebughna Challenge update: Ten students met the challenge of academic growth, great attendance and positive attitude and will be attending Sea Life Center on April 12th and 13th.

d. Personalized Learning/Educational Elements-Update (Saw plkpbsd.org): We shared this website and explained different aspects of our Wave 3 start up of Personalized Learning. We are all excited to proceed.

e. Upcoming activities (Bingo For Books, Winter Bear, Identity Week, Prom, Game Night, Art Residency-Eddie Woods): All were shared with Site Council.

f. Testing: AIMS/Ed Performance; PEAKS/MAPS: We discussed that we have completed PEAKS and will begin our Universal Testing tools (AIMSweb and Ed Performance) at the end of April. We also are a pilot school for MAPS and Mr. Allen and Christy will be attending MAPS orientation in late May.

g. Two Star School Information: Tebughna School has had a "Two Star Rating" since at least 2013-2014 when our new State testing results were shared. Since SBA and AMPs were phased out, this testing year will be our first opportunity to change our rating with PEAKS being given for the second year.
